RECAPITULATION OF MITIGATION FEATURES For 7016 Pelican Bay Blvd,Bldg G

- 1. Building Code:** **Unknown or does not meet the requirements of Answer A or B**
Comments: The year of construction was verified as 1991 per Collier County Property Appraiser.
- 2. Roof Covering:** **FBC Equivalent**
Comments: The roof coverings were replaced in 2013. The roof permit was confirmed and the permit number is PRBD20130203339. This roof was verified as meeting the building code requirements outlined on the mitigation affidavit.
- 3. Roof Deck Attachment:** **Level C**
Comments: Inspection verified 1/2" plywood roof deck attached with 8d nails at a minimum 6" on the edge & 6" in the field.
- 4. Roof to Wall Attachment:** **Clips**
Comments: Inspection verified embedded straps fastened with a minimum of three nails.
- 5. Roof Geometry:** **Other Roof**
Comments: The roof shape is made up of a combination of flat and pitched sections. The flat area of the roof comprises approximately 21% of the total roof area. The hip portion of the roof comprises approximately 77% of the total roof perimeter. According to the wind mitigation affidavit this roof is rated as "Other".
- 6. SWR:** **Yes**
Comments: SWR was verified at time of inspection. The Secondary Water Resistance verified is a self-adhering peel and stick.
- 7. Opening Protection:** **None or Some Glazed Openings**
Comments: Inspection verified some metal shutter opening protection. Not all glazed openings were protected with impact resistant coverings.

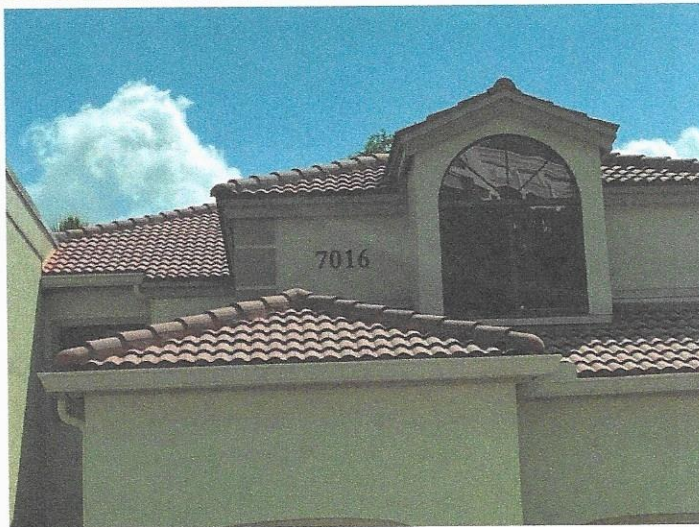

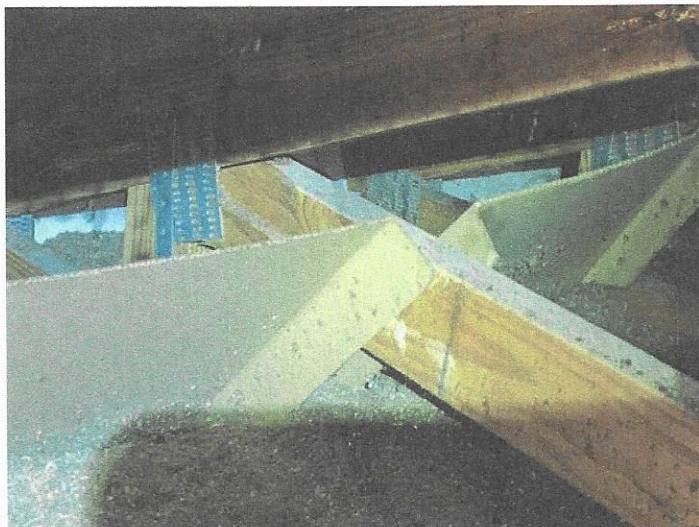


Exterior Elevation

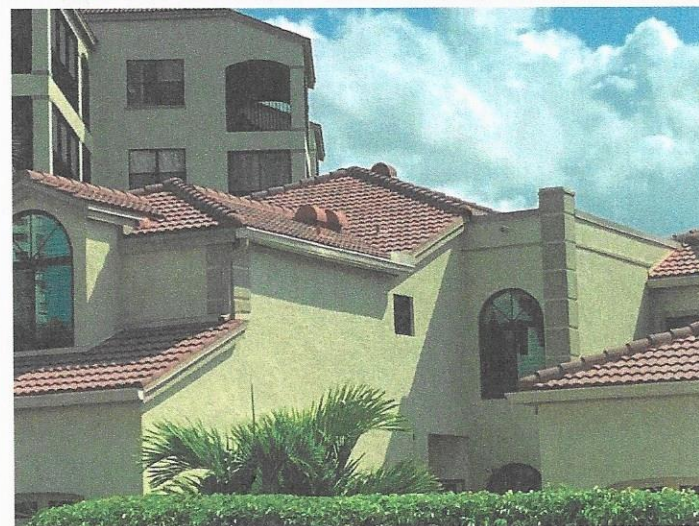

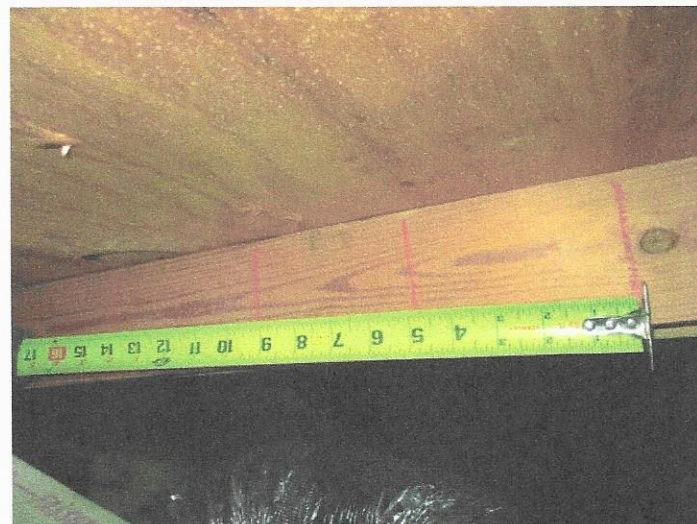

 - Metal connectors consisting of a single strap that wraps over the top of the truss/rafter, is secured to the wall on both sides, and is secured to the top plate with a minimum of three nails on each side.
