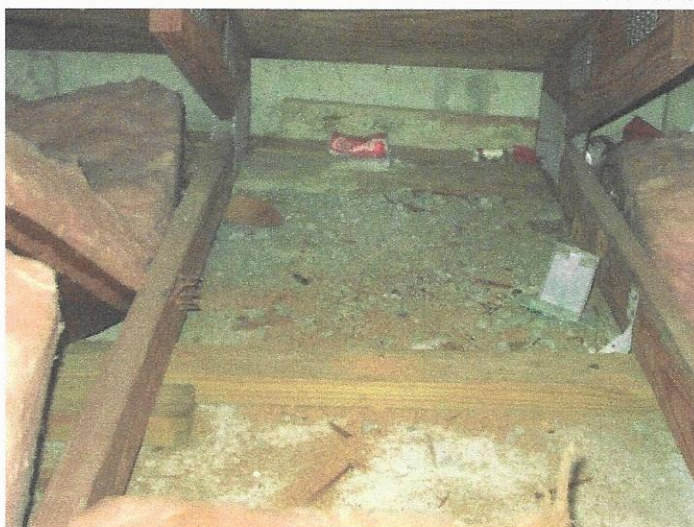

Comments: The year of construction was verified as 1991 per Collier County Property Appraiser.
- 2. Roof Covering:** **FBC Equivalent**  
Comments: The roof coverings were replaced in 2013. The roof permit was confirmed and the permit number is PRBD20130203340. This roof was verified as meeting the building code requirements outlined on the mitigation affidavit.
- 3. Roof Deck Attachment:** **Reinforced Concrete Roof Deck**  
Comments: Inspection verified a roof structure composed of cast-in-place or pre-cast structural concrete designed to be self-supporting and integrally attached to the wall / support system.
- 4. Roof to Wall Attachment:** **Structural**  
Comments: Inspection verified a roof structure composed of cast-in-place or pre-cast structural concrete designed to be self-supporting and integrally attached to the wall / support system.

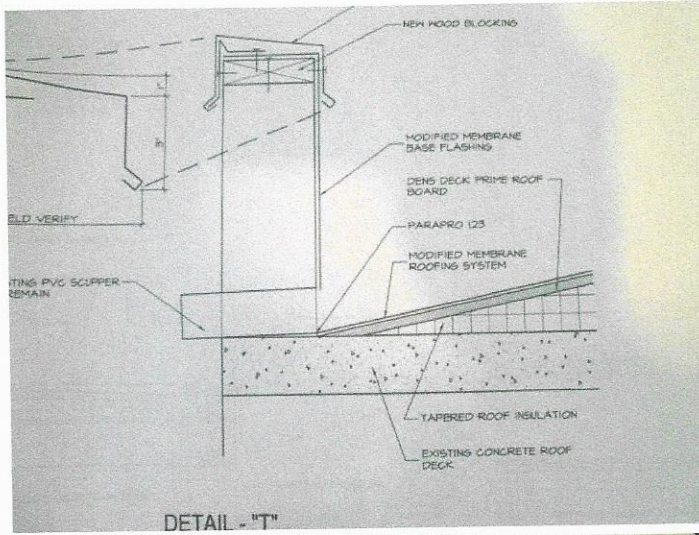


Exterior Elevation

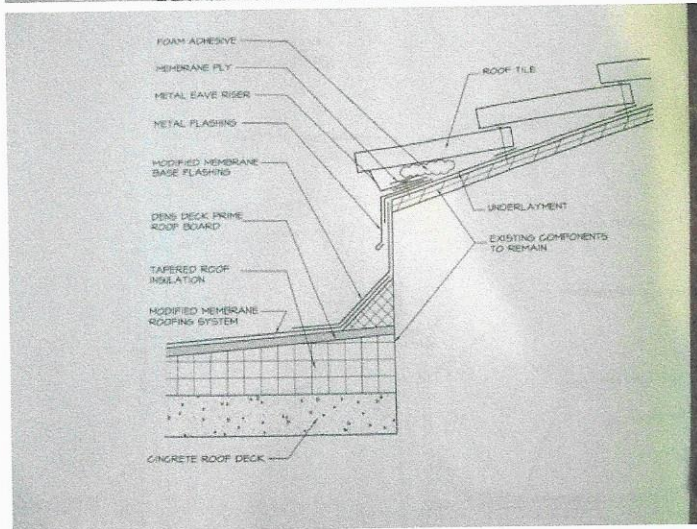

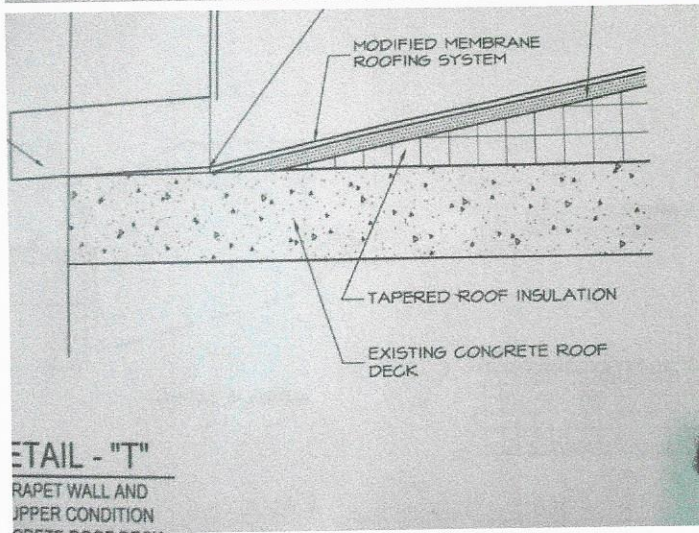

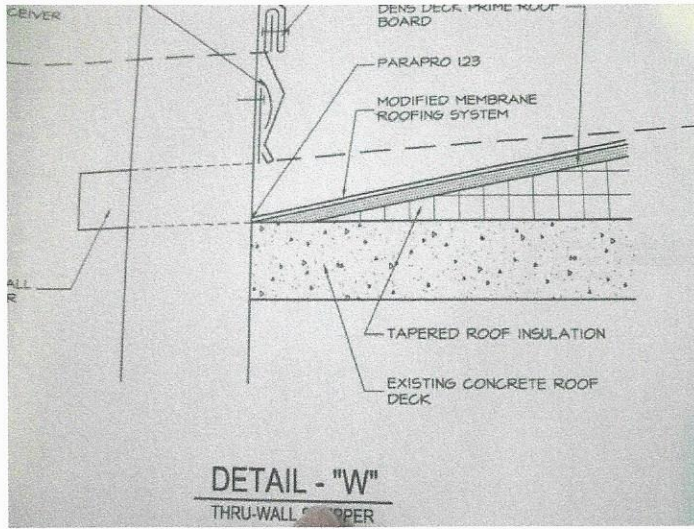
