This agreement does not provide for the control of termites, fungus, beetles, or any other pest not indicated herein.
- 2) **NOTICE OF CLAIMS.** Any claim under this agreement must be made during the term of this Agreement and in writing to any PestMax Control Solutions office. Failure to make such written claim during the term shall be a waiver of said claim.
- 3) **DISCLAIMER.**
 - a) PestMax Control Solutions liability under this Agreement will be terminated if PestMax Control Solutions is prevented from fulfilling its responsibilities under the terms of this agreement by reason of delays in transportation, shortages of fuel and/or materials, strikes, embargoes, fire, floods, quarantine restrictions, earthquakes, hurricanes or any other act of God or circumstances or cause beyond the control of PestMax Control Solutions.
 - b) PESTMAX CONTROL SOLUTIONS DISCLAIMS ANY LIABILITY FOR SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES. THE GUARANTEES STATED IN THIS AGREEMENT ARE GIVEN IN LIEU OF ANY OTHER GUARANTEE OR WARRANTY, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
- 4) **CHANGE IN LAW.** PestMax Control Solutions performs its services in accordance with the requirements of federal, state and local law. In the event of a change in existing law as it pertains to the services promised herein, PestMax Control Solutions reserves the right to revise the service charge or terminate this agreement.
- 5) **NON-PAYMENT.** In case of non-payment by the Purchaser, PestMax Control Solutions has the right to terminate this Agreement and reasonable attorney's fees and costs of collection shall be paid by the Purchaser, whether suit is filed or not. In addition, interest at the highest legal rate will be assessed for the period of delinquency.
- 6) **ENTIRE AGREEMENT.** This Agreement constitutes the entire Agreement between the parties and no other representations or statements will be binding upon the parties.
- 7) **ARBITRATION.** The Purchaser and PestMax Control Solutions agree that any controversy or claim between them arising out of or relating to this Agreement shall be settled exclusively by arbitration. Such arbitration shall be conducted in accordance with the Commercial Arbitration Rules then in force of the American Arbitration Association. The decision of the arbitrator shall be a final and binding resolution of the disagreement which may be entered as a judgment by any court of competent jurisdiction. Neither party shall sue the other where the basis of the suit is this Agreement other than for the enforcement of the arbitrator's decision. In no event shall either party be liable to the other for indirect, special, or consequential damages or loss of anticipated profits.
